Previous Meeting Minutes

Mid-State Health Network (MSHN) Update:

In Board Member, Joe Brehler's absence, there was not a MSHN report.

CEO REPORT

As part of the CEO Report, CEO, Sara Lurie welcomed Aleshia Echols back from medical leave and gave a special heartfelt acknowledgment to all of the CMHA-CEI Administrative Assistants who did an awesome job pitching in and helping cover the position of Executive Administrative Assistant, with a special thank you to Darby Vermeulen, who took on the responsibilities for CMHA-CEI Board relations, and Stephanie Stevens, who assisted with a variety of tasks. Thank you, thank you!

CEO, Lurie highlighted the following list of activities (not all inclusive) in which CMHA-CEI are involved in Eaton County which included:

- Eaton County Counseling Center, under the direction of Scott Struck, Supervisor
- Outpatient Services for Adults and Youths
- Jail and Youth Center (limited services)
- Waverly/St. Joseph Waverly Wellness Outpatient Center
- Eaton RESA Truancy Services
- Court Intervention and Diversion Program (screening with staff and connected with CMH or other behavioral health services)
- Integrated Community Youth Prevention and Outreach Services (2 positions)
- AMHS-Navigate offered to Charlotte teens through high school, and through the Delta Waverly library in addition to some psycho base services along with parenting classes and Stress Busters.
- Access Steering Committee in place to assist with accessing services as well as provides housing assistance.
- In-Home services provided in Eaton County by Families Forward staff

Additionally, CEO, Lurie was happy to report that CMHA-CEI has been able to expand quite a bit with our juvenile justice village with the integrated Youth outreach unit which we remain under contract. Additionally, we have added Peer Recovery Coaches who connect with the hospitals. However, noted that there are no substance use services provided by CMHA-CEI, noting that those services are provided through MSHN outpatient program in Charlotte through Samaritas' SUD services.

Board member, Paula Yensen inquired as to whether CEI leadership felt there were any gaps in the Eaton County?

CEO, Sara Lurie commented that there is a general shortage in mental health services overall. However, stated that she feels that CEI has done a good job filling the gaps

with the support of the Eaton Rapids Hospital Substance Use Disorder Services, under CCBHC, at Eaton Counseling Center. Waverly Wellness Outpatient Center, and Eaton Counseling Center.

Other services available in Charlotte include the Teen Health Clinic which is provided by a grant through Eaton-RESA for behavioral health services for schools. Sparrow partners and provides the medical services, and CMHA-CEI provides the mental health portion in which CMHA-CEI Families Forward program receives referrals.

Board member, Dwight Washington inquired as to whether CMHA-CEI contracts with ALIVE for any services and shared AL!VE offers health and wellness programs and services ranging from clinical services such as rehabilitation and weight management to non-clinical services such as fitness center, spa, cooking classes and children's programs. ALIVE is located at 800 Lawrence Avenue, Charlotte MI (just passed the hospital) and offers a variety of services. Conflict Free Access (focus services and separating intake, assessment, treatment planning, authorization from provision of services – concern is provider authorizing own care

CEO, Lurie shared that in addition to communicating with both government and federal elected officials, CMHAM has FOIA any communication between the state of Michigan and CMS as well as seeking legal opinion. In the meantime, CMHA-CEI has connected with Senator Sarah Anthony's office, and provided her with a copy of the infographics developed by CMHAM for her review and information.

ACTION: Documents will be reviewed to see if the plan violates any statues.

Medicaid Re-enrollment Deficit

CEO, Lurie reported that although our region is not affect, other CMHs are feeling the pain of the rate increases due to not hitting the mark and soaring numbers from 2 million to 80 million in deficits.

County Commission Resolution Update

CEO, Lurie reported that Ingham, Eaton has passed, Clinton is pending.

HCBS Rule Change

Board member, Paul Palmer shared that the HCBS rules came out in 2014, which focused on settings explaining that the HCBS are Medicaid services for people with disabilities to help them live in their own homes and communities.

Why is the rrule Important? It will: ensure individuals who have disabilities have the same access to the community as individuals who do not have disabilities.

Board member, Dwight Washington inquired as to who is supporting the new legislation? CEO, Lurie clarified that this is not a change in legislation, rather a federal rule change which states are looking at implementing due to fines. CEO, Lurie confirmed that there is nothing happening in the public related to this as it is all at the department level.

<u>U-M Health-Sparrow proposes new psychiatric hospital at former Lansing high</u>
Board member, Paula Yensen shared that as a private citizen she is in support of a new psychiatric hospital, and has shared her personal views on Facebook opposing the Lansing high school site due to the historical nature of the building as well sentimental value for the property sharing the she previously attended Eastern High School as a youth.

CMHA-CEI and U-M Health-Sparrow Board member, Timothy Hanna assured Board member, Yensen that UofM Health Sparrow Board of Directors are only in beginning stages of the discussion, and that no plan is in place at this time. Additionally, they are aware of the citizens' concerns regarding the significance of the building, and consideration will be given to incorporate historic value (wood work, fixtures) of the building, noting that the building in its' current state is not equipped to house a behavioral health hospital.

Below please find a copy of the Lansing State Journal article dated June 7, 2024: Lansing State Journal LANSING — University of Michigan Health-Sparrow is aiming to build a \$97.2 million psychiatric facility at the former Lansing Eastern High School site.

Health system officials said Friday they have asked the state to approve certificates of need for 120 beds. That's a required step before hospital systems can expand, and should the state grant approval the U-M Board of Regents will be asked to sign off on the proposal.

U-M officials said the former high school campus, located directly north of Sparrow's main Michigan Avenue campus, is the right site because of its proximity to the existing hospital and emergency department at 1215 E. Michigan Ave.

The high school building has been closed for years and has a "dilapidated interior (that) makes it unsafe and cost-prohibitive to locate any services there," spokesperson John Foren said in a statement.

The health system said the project will include working with school alumni and community members to preserve the history of the school with the expectation of submitting a final proposal to the university's Board of Regents in the next few months.

Surgeon General Report

Board member, Yensen highlighted the article shared by CEO, Lurie in this month's CEO Report regarding the impact social media platforms are having on MH Issues, specifically children and the recommendations.

CEO, Lurie commented that there has been increases in school base issues such as bullying and it is raising a lot of discussion and the rebuttal has been hat social media is a lifeline for many youths as this is one way of expression through selfies, noting that another area of concern is use of cell phones in schools as it has had a major impact on student learning.

CEO, Lurie stated that there are some things that can be done to reduce the negative impacts which include parents.

Board member, Dwight Washington thanked everyone for the good dialogue during this evenings CEO Report.
