Call to Order:

The meeting was called to order at 6:02 p.m. by Chairperson, Carol Koenig.

Approval of Meeting Minutes:

Mid-State Health Network Update:

Joe Brehler, Sara Lurie and Ericanne Spence attended the September 6, 2016, MSHN Board of Directors meeting held in Stanton, Michigan. Mr. Brehler reported that during the meeting all contracts were approved for next fiscal year; with the vote being 21 – 3. Mr. Brehler went on record with a "no" vote and expressed concern regarding the fact that although all providers had seen the contract, there was no mention of the fact that there were no contract dollar amounts included. For that reason, Mr. Brehler made a request to table this item until the October meeting. He was informed that if the item was tabled, none of the providers would receive payments for that month. That being said, contracts were approved.

Ericanne Spence, Director of Substance Abuse Services Administration & Corrections Mental Health reported that due to the significant impact that the transition from Cost Reimbursement to Fee-for-Service model will have on Substance Abuse programs CMHA-CEI has been assured a three-month contract extension. In addition, MSHN has agreed to continue to work with CEI regarding further funding. At this time, it is unknown how much money will be available after December 31, 2016.

CEO Report

Sara Lurie, Chief Executive Officer kicked off the CEO Report with some good news, sharing that this week, we received some unexpected funds in the form of adjustor payments related to our 2015 Children's Waiver and SED Waiver expenses. These payments from the state are not predictable from year to year, but when received can be used similarly as local funds. We also received additional news that we will be receiving a Section 236 transfer of unused general funds from The Right Door (Ionia County's CMH).

The combination of these recently received funds will likely allow us to end the fiscal year without a deficit. While we will absolutely need to continue our efforts to be vigilant in monitoring our general fund spending in 2017, ending this year without a deficit to overcome in our fund balance is a huge relief. In addition, Ms. Lurie reported that Michigan Department of Health and Human Services (MDHHS) approved the revised script and proposed consent forms for the revised guideline #6.2.8.1, evaluation for psychiatric hospitalization for children with commercial insurance, and briefly touched on the recent Lansing State Journal article that was published.

Ms. Lurie then introduced Mr. Robert Sheehan, Michigan Association of Community Mental Health Board, Chief Executive Officer. Mr. Sheehan provided an overview and some insight during his report on the following items:

- Section 298,
- Affinity Workgroups and Town Hall meetings for Eligible Populations and Families that are current taking place in Oakland and Macomb Counties,
- CCBHC funding process and the fact that CCBHC is the wave of the future.

Mr. Sheehan engaged in a thorough discussion regarding the above items and fielded several questions regarding privatization and efforts in place to retain both the physical and behavioral public mental health system.
