Call to Order:

The meeting was called to order by Chairperson Joe Brehler at 5:30 p.m.

BUSINESS ITEMS:

Bundled: Direct Care Worker Increase

Shana Badgley presented a bundled contract for a 50 cent hourly increase for direct care workers. The board had previously approved a 1% wage increase for all contractors in September 2017. Discussion ensued as to the requirements of the contract, which includes the services listed in the Services Description section of the table. The state gave CEI an increase in Medicaid dollars to pay this increased rate.

Old Business:

Stacia Chick provided an update on the audit. The single audit and compliance audit are waiting to be reviewed by a partner. The auditors are waiting on the expense testing and the expense tie-out to the FSR. The audit should be completed by November 30, as reported by Plante Moran last month. Joe Brehler confirmed that Plante Moran relayed to him that the audit would be done by November 30. Stacia reported there will be two findings on the audit, the late financial statements and the late Ability to Pay document from one encounter that was pulled.

New Business:

Sara Lurie discussed a visit she had with an attorney for a class action lawsuit for the opiate addiction issue, including the over-prescription of opiates by doctors. This is focused on localities (cities, counties) and these locales would receive the pay-out from the suit. The lawsuit could take 2-5 years. City of Lansing will be signing on for the lawsuit. Discussion ensued as to where the funds would be allocated if the municipalities were to receive them.
