Call to Order:

The meeting was called to order by Chairperson Joe Brehler at 5:30 p.m.

Previous Meeting Minutes:

MOVED by Kay Randolph-Back and SUPPORTED by Chris Swope to approve the meeting minutes of February 13th, 2019, with the amendment of changing the language at the bottom of page 5 to read, "She went on to say she didn't feel right about paying in the future for the assessment for those with commercial insurance with general fund dollars, but raising the rent for those in Supportive Housing."

Expense Contract Amendment: Peckham, Inc

John Peiffer again presented the contract with Peckham, asking for an extension of three months so he and HR can work on job descriptions, setting pay grades, etc. John and HR will be in communication with Peckham throughout the process in hopes to hire many employees directly from Peckham.

ACTION:

MOVED by Chris Swope and SUPPORTED by Kay Randolph-Back that the Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to amend the existing contract for three additional months beginning April 1, 2019 and ending June 30, 2019. By purchasing janitorial services from Peckham, Inc. located at 3510 Capital City Blvd Lansing, MI 48906-2102 in Ingham County, their employees will provide janitorial cleaning services for Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) at both 812 East Jolly Road, and 1305 Jolly Road locations in Lansing Michigan, 48910. This is for the period of April 1, 2019 through June 30, 2019 at a rate of \$21,284.35 per month.

Expense Contract Lease Renewal: 201 Railroad, St. Johns

John Peiffer presented a lease contract for the building at the Clinton County Counseling Center. This will extend the existing lease with a slight modification in square footage for three months.

MOVED by Kay Randolph-Back and SUPPORTED by Chris Swope that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to lease space at 201 Railroad, St Johns containing 7272 square feet, from Huntington Bank 5555 Cleveland Ave., GW1097, Columbus Ohio 43231 and pay the following lease rates for the next three years:

The rental rates for the period reflect a 2% increase per year per article (35) of the existing lease and those rates will be effective as follows:

MOVED by Chris Swope and SUPPORTED by Jim Rundborg that the Finance Committee recommends that the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties authorize CMHA-CEI to renew a contract with the Ingham County Health Department and provide 7.0 FTE staff and .75 FTE clinical supervision to support the behavioral health program embedded within the eight Ingham County Health Department Clinics for the retroactive period of October 1, 2018 through September 30, 2019 and receive \$720,000 for those services.
