Lynn Roper presented a renewal to purchase respite services to increase the availability of services for children on the children's waiver.

MOVED by Dianne Holman and SUPPORTED by Dave Pohl that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into a contract renewal with CranHill Ranch and purchase respite services for the retroactive period of January 1, 2020 through September 30, 2020 and pay per the rate schedule below.

Expense Contract Change Order: Rehmann Robson Financial Outsourcing Services
Stacia Chick presented a change order to the contract with Rehmann Robson. An
additional staff member was added to the current roster. Dave asked if there is a cap
on the dollar amounts paid out for these services, and Stacia said the Finance budget
is her guide to how much can be spent. She went on to explain that RR has been
brought on to supplement the Accounting area, as the two current accountants staffed
by CEI are new to governmental accounting. Stacia will eventually post the
accounting position, potentially after the audit has been completed. She went on to
say that the software implementation makes it more difficult to hire a new
accountant at the moment.

#### **ACTION:**

<sup>\*\*</sup> Families may choose to utilize their respite authorization to pay a portion of camp costs. Payment from CMHA-CEI to IKUS will be the rate less any amount paid to IKUS by the family or scholarship funds.

Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into a contract change order with Rehmann Robson to purchase Financial Outsourcing Services for the Finance Department in addition to those services previously agreed upon and pay a flat rate of \$125 per actual hour worked January 6, 2020 through July 31, 2021 and thereafter month to month, plus reimbursement for actual out of pocket expenses. The contract term is from January 6, 2020 through July 31, 2021 and thereafter month to month for those services until terminated by either party following a 60-day written notice.

# Expense Contract Amendment: Connie Srebnik – Srebnik's AFC

Stacia presented this item for an individual who was placed out of county for a very short period of time. The level of care needed for this individual is much higher than CEI normally sees, and the provider is looking for funds to cover that additional care. CEI does not currently have a contract with Srebnik's AFC.

#### **ACTION:**

MOVED by Dave Pohl and SUPPORTED by Raul Gonzales that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to enter into a contract amendment with Connie Srebnik to purchase specialized residential services for one consumer with an increased level of care at the location listed below and pay a per diem rate of \$120.00 for service codes H2016 and T1020, independent of any amount paid to the home for room and board as calculated in the consumer's ability to pay, for the retroactive period of September 4, 2019 through September 12, 2019.

# FY2020 Medicaid Revenue Update - For Information Only

Stacia Chick presented a Medicaid Revenue update to the committee. She reminded the group that going into Steady State, CEI did not have final rates from the State and MSHN's projections were lower than CEI's projections. Stacia went on to say if the revenue is projected out through 2020, we will be under budget by about \$3.7M. However, there were some issues that arose from the first 3 months of 2019, i.e., CEI wasn't paid for services for several individuals. We will be receiving those funds by January 16, so Stacia will know more then. Once we know how the State will be correcting the payments, the projections will be more accurate. Stacia recommended monitoring future payments to ensure this doesn't happen again, starting with January payments.

Stacia said CEI is looking at lapsing significantly less for 2019 than previous years.
