Expense Contract Renewal: AT&T 1 Gigabit Internet Connection

Joanne Holland presented this three-year renewal. The cost decreased slightly from the last contract.

ACTION:

MOVED by Raul Gonzales and SUPPORTED by Kay Randolph-Back that the Finance Committee recommends that the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties Board of Directors authorize CMHA-CEI to renew its contract with AT&T for Internet services for the period of April 1, 2020 to March 31, 2023, for a total amount of approximately \$87,516.

FY2020 Medicaid Revenue Update – For Information Only

Stacia Chick said that the Medicaid revenue totals went from trending under by \$5.5M to trending under by \$805k. Stacia said all of the revenue on the spreadsheet is capitated Medicaid. She doesn't think program proposals for cuts are necessary at this time. Stacia went on to say the overall budget is \$120M, so the \$805k amount is pretty insignificant. She said there are a few programs who are underspending at this time, anyway. Jim Rundborg asked if COVID19 could affect this number, and Stacia said that it could affect it. She went on to say the COVID19 Taskforce is looking at any potential service impacts. Stacia said that telemedicine could be more heavily used in the case of a spread of the virus in our region, but any services not approved in the Medicaid manual would not be able to be charged to Medicaid, unless we are given exemptions from MDHHS or MSHN. Joe also noted if the Medicaid dollars are not expended, that money needs to be given back. Kay complimented Stacia on the construction of the spreadsheet as she felt it was well laid-out.
