Mid State Health Network Update

Joe Brehler reported that MSHN Board met. Much of the discussion revolved around

the COVID-19 pandemic. Highlight from the meeting included Mid-State Health Network Board's recent Authorization of an extension of Premium Pay through January 9, 2021.

CEO Report

Sara Lurie reported that a copy of the full CEO Report could be found in the September board packet. However, she wanted to take a moment to share how much staff sincerely appreciated the efforts of the board with regards to the recent mailing of commendation letters to all employee homes as well as the gift cards that were mailed out to 60 employees based on the random drawings. Ms. Lurie shared that she received many positive comments from staff via email and in passing in the hallways regarding how much staff appreciated the thoughtfulness of the CMHA-CEI Board of Directors.

Special thanks to Dwight Washington and Kay Randolph-Back for their participation on the Board of Directors Employee Recognition workgroup to spearhead those efforts.

Other highlights from the CEO Report included:

- State Budget
- Increased Healthy Michigan Enrollments/Funding
- Fee Schedule Development

Sara mentioned that the state budget is coming along and should be available within the next week or so. However, to date, it has not been determined if CMHA-CEI will experience any reductions or if there will be any changes that will impact CMHA-CEI and reported that we were taken by surprised at the end of the FY, in terms of the increased enrollment/funding, reporting that starting in May, Medicaid and particularly Healthy Michigan enrollments increased at numbers higher than predicted and has resulted in \$31 million of revenue that was never identified or planned for. With that being said, if there are some state budget cuts, the increased enrollments might help provide a cushion.

Additionally, MDHHS is hosting a series of meetings for providers and CMHs around Fee Schedule Development. This is something we will be keeping an eye on because it looks like they are trying to develop a fee for service type system, although CMHs will not be held to the fee schedule, they need that to be able to compare and understand the differences in populations and in locations. There has been a lot of participation in the meetings and people are asking a lot of questions so that

Kay Randolph-Back commented, expressing her appreciation that this item was included as part of the CEO Report this month and welcomed an opportunity to continue to receive updates along the way and alerts if there is something that board members can do along the way. Additionally, Ms. Randolph-Back stated that this item was a big topic at the Legislative & Policy Committee and the state Association Executive Board. During that meeting it was shared that there was some basic lack of knowledge by the actuaries about what the code calls for and how the system works.

ACTION: Sara Lurie will keep the board members abreast of any updated information regarding the Fee Schedule development and will alert board members if necessary to solicit advocating around this topic as the consequences could be very negative.

^{*} On rare occasions, consumers may be admitted to the hospital who require substantially higher amounts of one to one staffing than is typical, due to highly aggressive or self-injurious behavior. Payor shall prior authorize up to two days Enchanted Staffing Inpatient Psychiatric Services for Consumers in this situation on a case by case basis. Provider Requirements:

Only those providers that agree to the following provider requirements will receive the adjustments:

- In all cases, all documentation requirements of this guidance shall be followed:
 - Employee Wage Attestation (wage verification) signed by the direct care worker employee and maintained by the employer;
 - and a MSHN Direct Care Worker Spreadsheet completed by the provider and provided to CMHA-CEI;
 - and must agree and submit to an audit against payroll records to confirm that the direct care worker adjustment was received;
 - and any other documentation requirements that may be required by MDHHS or Mid-State Health Network.
- In all cases, the provider direct care worker employee receiving the increase must be delivering services during the eligibility period of 4/1/20 to 09/30/20 (NOTE: Now 09/30/20 under SB 690, signed 07/01/20). Employees not delivering the eligible service code services are excluded.

This temporary program is intended exclusively to provide additional compensation for direct care workers providing "hands on"/direct services and supports to individuals.

CMHA-CEI Expectations:

• Contract amendments executed by CMHA-CEI and provider shall include language that:

Per diem adjustments (or unit rate adjustments in the case of timebased units of service) provided under this temporary program are subject to offset against any state or federal funds received by the provider for the same purpose over the same period of time.
