New Expense Contract: Royal Care Link

Karla Block presented this contract designed to ensure a provider who provides CLS/Respite will not be harmed in the switch of billing codes. This will ensure that we have a means to fill the gap in payments owed to the provider. Karla went on to say we are moving into Provider Access at the same time, so between that and the code change, it is the perfect storm for billing issues. This will take us additional time to turn around and pay the provider, and this contract ensures the provider will be paid in a timely manner.

ACTION:

MOVED by Jim Rundborg and SUPPORTED by Al Platt that the Program and Planning Committee of the CMHA-CEI Board of Directors authorize CMHA-CEI to enter into a new contract to advance payment for the purchase of Community Living Supports (CLS) and Respite Services from Royal Care Link on a bi-weekly basis up to the amount of \$30,000 for the period of October 1, 2020 through September 30, 2021. This advance shall be repaid in full through a withhold from subsequent contract payments or due in full 15 calendar days after termination of CLS and Respite Services,

whichever occurs first. This agreement shall terminate immediately at the sole discretion of CMHA-CEI.
