FY21 Revenue Contract Amendment: Mid-State Health Network
Ericanne Spence presented this contract amendment for block grant reductions.

The amount of the contract with the \$105,330 reduction is \$1,328,818 for Cost Reimbursed programs. Fee for Service programs are not capitated.
