The meeting was called to order by Chairperson Joe Brehler at 5:33 p.m.

BUSINESS ITEMS:

The following business items were discussed but not voted on because there was not a quorum present.

New Expense Contract: 2023 Vehicle Purchase

John Peiffer presented a new contract for 12 new vehicles. He said we are purchasing Ford Escapes, Explorers, and F-250. John said our current number of vehicles is 110, down from 140 previously. The goal is to have about 100 vehicles. John is looking to sell ten of the older vans in the near future.

Kay asked what John's process is regarding finding buyers for vehicles? John said either word of mouth or the agency-wide email AllNews, but we do better with word of mouth. CEI has not traded-in vehicles in the past because the Blue Book value is usually much higher than the trade-in price. Joe said he does expect this item to be approved at the Board meeting this month, even though it cannot be voted on without a quorum tonight.

Medicaid Revenue Update

Sue Panetta presented the update through January. The dollars continue to increase; there will be two more months of this before reenrollments start. Sue spoke with Amy Rottman because we are seeing a consistent upwards trend this year, which we didn't see from last year because we are still seeing enrollments. We are significantly over budget through the first four months by \$10M. Sue said we should see numbers start to even out. Amy heard there will be about 400,000 folks that will drop off

Medicaid because of the reenrollment, with a 2-3% drop each month. Sara said the State has not issued an official plan with enrollments starting in June.

Kay said some people who will be losing Medicaid have become CMH clients, so they are receiving care, have established therapist relations, etc. This says to Kay that they are not only losing a payor, they are losing the relationships that are vital to managing their mental illness. Kay said perhaps CCBHC money should be used when a person is losing Medicaid but already enrolled in services here. Sara said the reenrollment will be a similar situation to when we had a huge general fund cut and we will need to evalute how to continue serving folks with GF, millage dollars, and CCBHC. She noted that we have only spent about 25% of the millage dollars during the pandemic. Kay said she would like Finance Committee to be kept up to date on how many of these clients that are losing Medicaid we are encountering. Sue said we will know if we have active consumers who lose Medicaid. Sara said it's possible we will have more information from the State next month.
