<u>New Revenue Contract: Barry Eaton District Health Department – Eaton</u> <u>County Peer Recovery Coach</u>

Joyce Tunnard said we were approached by Eaton County with the request that we provide staffing for and supervision of a Peer Recovery Coach position. She said we have a lot of peer recovery at CEI – because of the funding we get from MSHN for these folks, their services are not billable and we can be a bit more flexible. This is actually a five-year grant.

Marie Carrell presented this contract for specialized psych services for CSDD. They are having capacity issues and there is specialized testing that has to be completed. This also opens the avenue of second opinions for families. Lynn was an employee at CEI for quite some time.

Revisions included adding a bit more information about the CSU, as the P&P Committee had wanted to see additional info regarding what will be available in the Crisis Stabilization Unit. Many of the acronyms in the plan were written out fully, at Board members' request.

Sara said over the last month, the Directors and Jan Urban Lurain went through each goal and tried to order them chronologically and align the objectives with the strategies. She said the approved plan will also be turned into an Executive Summary to send out to the community and partners.

Paula said the plan was really well done; she particularly enjoyed the portion on innovation and being creative in looking toward the future, and diversifying funding streams after COVID. Paula said since she is now serving on the Finance Committee, it's important to think of the future of funding. She was very impressed with the document.

SUMMARY OF CONTRACT/PROPOSAL:

Under this contract, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will purchase Applied Behavioral Analysis (ABA) services from:

CMHA-CEI will pay the rates as outlined in the chart below for assessments, direct therapy, required supervision, and family guidance by a Board Certified Behavior Analyst (BCBA) or other appropriately credentialed individual for the period April 1, 2024 through September 30, 2024.

The CMHA-CEI FY24 budget contains approximately \$9M for contracted autism services. The Autism benefit, is an entitlement benefit, requiring CMHA-CEI to serve those that meet the criteria for the service. The administration of this program will be included in the costs to be reimbursed by the Michigan Department of Health and Human Services (MDHHS). This contract will not affect CMHA-CEI's fund balance.

DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/PROPOSAL:

ABA is an intensive face to face therapy, designed to assist the child to develop age appropriate skills and to address the key symptoms of ASD. While symptoms vary in severity; common symptoms of ASD include deficits in the area of communication and interactional skills. In addition, some children may exhibit repetitive, disruptive and/or intrusive, behavior. ABA is typically provided several hours a week in a clinical setting, community, and/or in the child's home. Hours authorized per week are dependent on the needs of the child. The Medicaid policy requires that supervision of the therapy occurs by a Board Certified Behavior Analyst, (or other appropriately credentialed individual supervised by a BCBA) one hour for every 10 hours of therapy provided. Family training and involvement in the therapy, is a key component of the intervention. A CMHA-CEI psychologist will designate the level of service for which the child is eligible. In addition, MDHHS will verify the eligibility for each child.

STAFF RECOMMENDATION:

Staff recommends that the Program and Planning Committee of the Board of Directors of Community Mental Health Authority of Clinton, Eaton, and Ingham Counties approve the following resolution:

The Program and Planning Committee recommends that the Community Mental Health Authority of Clinton, Eaton, Ingham Counties Board of Directors authorize CMHA-CEI to enter into a contract with Advance ABA Care to provide the services at the rates listed below, for the period of April 1, 2024 through September 30, 2024.
