Call to Order:

The meeting was called to order by Chairperson Raul Gonzales at 5:30 p.m.

Previous Meeting Minutes:

MOVED by Paul Palmer and SUPPORTED by Jim Rundborg to approve the meeting minutes of January 9, 2017.

BUSINESS ITEMS:

New Expense Contract: Pine Rest Christian Mental Health Services

Jennifer Stanley presented a new contract with Pine Rest Christian Mental Health Services to purchase telepsychiatry services. CMHA-CEI has a shortage of psychiatrists and has experienced large gaps in the ability to provide services. Staff have investigated many options to close the gaps and are considering telepsychiatry. CMHA-CEI staff have been able to meet with the physician via teleconference. The proposal includes a rate of \$165 per hour for 40 hours per week, 52 weeks per year, for a total cost of \$343,200 per year. Additional negotiations include an extended termination clause. CMHA-CEI traditionally includes language for the ability to cancel an agreement with 30 days written notice. Pine Rest is requesting 90 days. The term of the agreement is also extended through 2018 due to the shortage of psychiatrists.

Discussion ensued regarding psychiatry shortage, demand, funding, and funding sources.

Dr. Stanley reviewed credentialing requirements and the interview process. CMHA-CEI is intending to use this service for the Adult Mental Health Services and Families Forward programs for adult and child medical evaluations.

ACTION:

MOVED by Paul Palmer and SUPPORTED by Jim Rundborg that the Program and Planning Committee recommends that the Board of Directors of the Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) authorize CMHA-CEI to enter into a new contract with Pine Rest Christian Mental Health Services to purchase telepsychiatry services for the period of March 1, 2017 through September 30, 2018 and pay \$343,200 per year for those services.

Joe Brehler shared concerns regarding the rate and sustaining services. Sara Lurie commented that CMHA-CEI should use a variety of resources in the future, including

nurse practitioners and telepsychiatry, but the current focus is the opportunity to fill a critical gap in order to strengthen CMHA-CEI's ability to serve. CMHA-CEI is still actively recruiting staff psychiatrists. The Program and Planning Committee requested a layout of comparative costs for hiring a staff psychiatrist, including the costs of salary, benefits, and insurance. Dr. Stanley will bring the information to the February Board of Directors Meeting.

Paul Palmer excused himself from the meeting at 6:00 p.m.

New Expense Contract: Listening Ear

Mary Clissold presented a new contract with Listening Ear to purchase community living supports and respite services. Listening Ear is a facility located in Standish, MI. CMHA-CEI staff had the necessity to secure this agreement for a family on an emergency basis, resulting in a retroactive start date.

Alan Platt presented a revenue contract with the City of Lansing that was previously approved for a different term and dollar amount. The new amount of \$20,000 will be used during CMHA-CEI's fiscal year. The term of the contract is for the City of Lansing's fiscal year. The Bridges Crisis Unit has constant general fund costs because CMHA-CEI provides beds to individuals without Medicaid. The City of Lansing was able to provide funding to apply to the general fund costs.
