## Mid-State Health Network Update

CMHA-CEI Board of Director, Tim Hanna reported that MSHN has not met since the last CMHA-CEI Board of Director's meeting. The next meeting is scheduled for September 9, 2025.

#### **CEO Report**

CEO, Sara Lurie presented the August CEO Report. Highlights from the report included the following:

#### Introduction of Laticha Taylor, CSDD Residential Technician

CEO Lurie introduced Ms. Taylor sharing that she has worked for CMHA-CEI for 7 years, and is currently a regular residential technician in the Developmental Disabilities department at the Howell Road Home and currently attends Liberty University as a Worship Studies major. Ms. Taylor reached out on her own with an interest to shadow the CEO to learn what a day in the life of a CEO looks like. We are happy to have her with us this evening.

### Resignation of Board Member, Al Platt

On behalf of the CMHA-CEI Board of Directors, CEO Lurie announced the resignation of Board Member, Al Platt effective Monday, August 8, 2025 on the CMHA-CEI Board of Directors commenting that Al is an amazing human being, attorney and retired employee of CMHA-CEI, and will be sorely missed.

ACTION: CEO, Lurie solicited suggestions from board members regarding what we can do as a board/organization to support Mr. Platt, and encouraged members to feel free to give him a call to see if he is up to a visit or some delicious baked goods!

ACTION: CEO, Lurie will notify Ingham County of vacancy by September 1.

#### **Crisis Stabilization Center**

CEO Lurie reported that in spite of uncertainty, we continue to forge ahead and make headway. On August 5th, during the Directors Group retreat held at the Child & Family Charities building, Directors toured the construction site which is about 50% complete beginning at the top floor; working down to the first floor, including drywall and painting with framing only on the first floor.

## **Executive Drive Update**

Sara shared that at the conclusion of the retreat Directors toured the Executive Drive property and are excited about the future possibilities of this space reporting that CATA is looking at deviation off current route nearby to service the building and reported that we are looking to close before September 30, 2025; excluding the parking area Lafontaine will retain.

Board Member Dwight Washington inquired as to whether we will have enough parking for staff if we allow Lafontaine to retain some of the parking. CEO Lurie and CFO, Sue Panetta reassured the board that there would be sufficient parking for staff.

ACTION: John Peiffer is looking at what type of renovations are needed to the Executive

Drive property to determine if work can be completed in-house by CMHA-CEI staff.

## **Space Planning**

CEO, Sara Lurie reported that during the Directors Retreat, a variety of scenarios were presented seeking input and feedback for further consideration by engineering.

ACTION: CFO, Sue Panetta; Properties and Facilities Manager, John Peiffer and CEO, Lurie will continue to meet to review and identify which scenarios will be presented to Collier as we will need to determine if what we would like to do is even possible based on actual space. Stay tuned.

ACTION: Piper & Gold is working on a quarterly press release regarding the Crisis Stabilization Center. Once finalized, a staff walk through will be scheduled for the fall.

#### PIHP Rebid

CEO Lurie reported that she has been in meetings daily with other CMHs regarding this matter and these are very tumultuous, stressful times. However, advocacy is still actively underway to stop the rebid process amidst the State issuing an RFP on August 4 to change how Medicaid funds for mental health services are managed. Right now, 10 public PIHP regions oversee those funds. The State wants to reduce that to three larger regions and has opened up bidding to include private managed care companies. The requirements for bidders announced have been expanded to allow private not for profit and a variety of public entities to apply. Analysis of the RFP shows that a current PIHP could apply but would be unlikely to meet the full scope of the requirements. The state accepted written questions from potential bidders and will respond to these questions on 9/5/2025. The due date for bidders has been changed to 10/6/2025 with implementation beginning 10/1/2026 (FY27). Based on communication, we have learned that a number of legislators are now strong opponents against the RFP.

Board Member Paul Yensen inquired as to what would happen if no one were to come forward to submit a bid.

CEO, Lurie advised that we know that the health plans will submit a bid. However, we are putting our energy into stopping MDHHS from moving forward, and this evening she plans to share information regarding litigation strategies that are underway.

<u>Child and Family Charities Non-profit Hub Open House 4 – 6pm</u> CEO Lurie extended an invitation to board members to attend the Child and Family Charities Nonprofit Hub Open House, 407 W. Green lawn vibrant new space where local nonprofits unite to support and strengthen the community. Join us for a hub-wide Grand Opening on Wednesday, August 27, from 4:00 – 6:00 PM.

ACTION: Dwight Washington inquired as to whether CMHA-CEI can have further discussions with Eatran-Eaton County Transportation Authority regarding county line boundary issue in the Tri-County explaining that based on contract, Clinton County blue bus, not allowed to transport to Eaton County.

Board Chair, Jeanne Pearl-Wright explained the work that is being done by Eatran/CATA to work things out and talked a little bit about the importance of the Delta millage.

Board Member Paul Yensen (in all due respect to the work that is being done) reiterated that it is a major barrier for those who seeking medical services over county lines and are on a tight budget and cannot afford transportation costs. Ms. Yensen shared a personal experience that resulted in out of pocket expense in excess of \$100 for transportation to seek services for her husband stating that they were blessed to be able to pay the \$100 out of pocket expense. Unfortunately, that is not the case for everyone!
