## SUMMARY OF CONTRACT/PROPOSAL:

Under this contract amendment, Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will purchase Community Living Supports from Anikare Inc. for the retroactive period of March 24, 2025 through September 30, 2025.

The expense of this contract is reflected in CMHA-CEI's FY2025 budget. The revenue sources that support the contracts are Medicaid, Healthy Michigan Plan (HMP), Habilitative Supports Waiver (HSW), Medicaid Spend-down/Deductible, State General fund dollars and other Community Mental Health Services Programs (CMHSP) through County of Financial Responsibility (COFR) agreements, and local funding. The expense of the contract is reflected in the various contract residential line items of the AMHS and CSDD residential budgets. The contract will not affect CMHA-CEI's fund balance.

# SUMMARY OF GOODS OR SERVICES REFERENCED IN THE CONTRACT/PROPOSAL:

Community Living Supports are provided by aides in the home or community setting to increase or maintain personal self-sufficiency, increase skills, build social skills and relationships, as well as participate in the community.

## SUMMARY OF CONTRACT/PROPOSAL:

Under this contract Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHA-CEI) will renew our existing Zix license and maintenance contract with Insight and pay \$31,904.24, covering June 1, 2025 through May 31, 2026.

The revenue and expense of this contract are reflected in CMHA-CEI's FY 2025 Budget. Because this is an indirect expense, all revenue sources support this contract. The expenses of this contract are reflected in the Maintenance line items of the Information Services (IS) budget. This contract will not affect CMHA-CEI's fund balance.

# <u>DESCRIPTION OF GOODS OR SERVICES REFERENCED IN CONTRACT/</u> <u>PROPOSAL</u>:

The security regulations of the Health Insurance Portability and Accountability Act (HIPAA) require that any consumer information emailed to parties outside of CMHA-CEI be encrypted. Since 2010, CMHA-CEI has used the Zix system to perform this function. It allows staff to encrypt email simply by putting the word "secure" anywhere in the subject line. It also scans all outgoing mail for the presence of protected health information, and automatically encrypts if detected.

# **SUMMARY OF CONTRACT/PROPOSAL:**

Community Mental Health Authority of Clinton, Eaton, and Ingham Counties (CMHACEI) is planning to replace the north half of the parking lot area with new asphalt at 812 East Jolly Road, Lansing Michigan. This asphalt work is being completed in order to replace and upgrade existing asphalt paving that is now 25 years old. Repaving will include improving the sub base to include compacted gravel per industry standards and best practices.

CMH-CEI Facilities staff are working with Wolverine Engineering company to oversee the work as we are recommending to enter into an expense contract with Tomco Asphalt, 3694 West Columbia Road Mason, Michigan 48854 for this project in the amount of \$303,727.25. All contractors associated with this project are to be paid at a prevailing wage.

The expense of these renovations will be allocated against the CMHA-CEI Ingham County Building Maintenance Fund in which CMHA-CEI will repay the amount in full to Ingham County at the completion of the project pending Ingham County Building Authority Project Approval.

The expenses of these renovations are reflected in CMHA-CEI's FY 2025 budget. The expense for renovations will not affect CMHA-CEI's fund balance.

## SUMMARY OF CONTRACT/PROPOSAL:

Under this purchase of property recommendation, Community Mental Health Authority of Clinton, Eaton and Ingham Counties is recommending that we enter into negotiations to purchase the building and property located at 5913 Executive Drive Lansing, Michigan 48911 from LAG (Lafontaine Auto Group) Executive Drive LLC., a Michigan limited liability company of 4000 West Highland Road Highland, Michigan 48357 as seller for the amount estimated between \$3,200,000 and \$4,200,000. A formal buy/sell agreement will be negotiated by both parties which is contingent upon CMHA-CEI Board of Directors Approval.

## About the building:

Year built: 1989

Condition: Good to excellent! Facility condition assessment will be completed prior to

purchase. Very well maintained. Square footage: 123,000 square feet

Prior owner: Jackson National Life Insurance Parking: 370 Spaces / 18 tagged as handicap

Example of Value: If the final purchase price comes in at \$3,500,000 that is equal to \$28.46

per square foot.

#### Own vs lease Impacts:

By purchasing 5913 Executive Drive there is the potential to consolidate the following leases to CMHA-CEI Owned property:

3500 S Cedar Suite 116 (AMHS ACT Program) 5500 sq. ft. at \$4,466 / monthly rent.

 $\underline{5913\ Executive\ Drive\ suite\ 200}$  (Families Forward) 15,000 sq. ft. at \$25,000 / monthly rent.

2316 S Cedar Street suite 205 (AMHS Housing and Residential) 3000 sq. ft. at \$4,222.50 / monthly rent.

405 Greenlawn suite 230 and 305 (ITRS and AMHS) 11626 sq. ft. at \$11,626 / monthly rent. A total of 35,125 sq. ft. for a total amount of \$45,314.50 / monthly rent.

Those lease dollars can be reallocated toward the building operations at Executive Drive.

#### Other considerations:

Purchasing 5913 Executive Drive provides the needed space in order to manage our future growth as an agency for CMHA-CEI programs as part of completing our long term master planning project and positioning CMHA-CEI well into the next 5 years and beyond.

An additional Fact Sheet for the purchase of the building and property will be provided in June.
